

Student Agreement

This Student Agreement (“Agreement”) is between SureShot Cincy LLC (“SureShot Cincy”) and the undersigned participant (“Student”). It is applicable to the course (“Course”) below:

Basic Pistol

The Student Agreement must be read and completed in full by the Student and returned to a SureShot Cincy LLC representative before the course begins.

Eligibility

In order to participate in the Course, the Student must meet the following criteria:

- Student is a United States citizen in good standing.
- Student is over the age of 21.
- Student is eligible to purchase and own a firearm (as outlined in ATF Form 4473).
 - Student must be not under indictment or information in any court for a felony or other crime for which the judge could imprison the Student for more than one year.
 - Student has never been convicted in any court of a felony, or any other crime, for which the judge could have imprisoned the Student for more than one year (even if a shorter sentence was received).
 - Student is not a fugitive of justice.
 - Student is not an unlawful user of or addicted to any controlled substance.
 - Student has never been adjudicated mentally defective OR have been unwillingly committed to a mental institution.
 - Student has not been discharged from the Armed Forces under dishonorable conditions.
 - Student has never been subject to a court order restraining the Student from harassing, stalking, or threatening another individual.
 - Student has never been convicted in court of a misdemeanor crime of domestic violence.
 - Student has never renounced United States citizenship.

Failure to meet any of the criteria above will disqualify the Student from participation. Student must provide proof of United States citizenship and age in the form of a government-issued form of identification.

Payment & Refund Policy

The Student agrees to pay a \$50 non-refundable deposit upon registration, which goes towards the total cost of the course. This is to procure locations such as classrooms and range time as well as teaching materials and student supplies, which will be issued by SureShot Cincy upon completion of the payment and at the beginning of the course only.

Should the Student cancel their enrollment in the course, any outstanding payments aside from the \$50 deposit will be returned. In the event that SureShot Cincy must cancel a course or session, the student may either receive a full refund or may transfer to another available class.

Student Agreement

The full payment for the class must be received before the class begins. Payment may be made in advance via credit card, cash, or money order - only cash is accepted for any outstanding fees on the day of the course.

Note that unless otherwise arranged, the Course fee does not include the cost of ammunition or use of loaner firearm. Should you elect to use a firearm provided by SureShot Cincy LLC, an additional fee for maintenance and ammunition will be applied.

Course Terms

SureShot Cincy will allow the Student entry into the course after the Student signs this Student Agreement. Student acknowledges that the course is optional and done of their own free will - no outside pressure, economic or physical, is forcing the Student to participate or to sign this agreement.

The Student agrees to follow all directions given by SureShot Cincy's agents (the "Instructor" or other designated figures, such as Range Officers) for the duration of the Course. The Student acknowledges that such directions are vital for the safety of all course participants. Failure to follow directions from the Instructor may result in the Student's ejection from the course without refund of any kind.

Waiver & Acceptance of Liability

SureShot Cincy is providing the Course for the benefit of the Student and others who desire to train in the use of basic pistol training. This course involves the use of live ammunition with real firearms.

SureShot Cincy will, to the best of its ability, provide a reasonably safe and effective training environment. However, the Student acknowledges that it is impossible to create an absolutely safe environment. Through this contract, the Student acknowledges this fact and assumes the risks associated with live ammunition and firearm training.

At any point during training, if the Student feels uncomfortable or unsafe, the Student agrees to let a SureShot Cincy representative know. Together, a reasonable alternative or solution will be discussed.

Student Agreement

The Student hereby absolves SureShot Cincy LLC of any damages the Student may experience while participating in the course. The Student agrees to hold SureShot Cincy LLC, its employees, and its agents harmless from any sort of injury or damage experienced by the Student in taking in the course. Student expressly waives any and all rights and causes of any action the Student may have for compensation at law and equity, including negligence, from SureShot Cincy LLC, its employees, or its agents in such event that the Student is injured and shall indemnify the same.
